- Group profile. A description of your group and its music or form of entertainment including performing highlights, personnel, in 150 words or less. Please attach the profile as a Microsoft Word document or include it in the body of an email.
- Photo. A digital photo of 300dpi, in JPG format file not to exceed three megabytes, attached to email is preferred. An 8"x10" black and white photo is also acceptable; please send to CAPAZ address above and advise via email.
- Plot plan. A diagram of the stage set-up for your performance.

An area near the stage will be designated for participating entertainers to sell CDs and promotional materials, and to meet the public after your performance. Please complete the form and return it with the Release and Waiver, your Group Profile, Photo, and Plot Plan by Wednesday, October 23, 2024. through email: phoenixcarnivalaz@gmail.com or via USPS to CAPAZ, P O Box 1594, Avondale, AZ 85323.
