Parade Rules, Regulations And Safety Requirements

"Sharing Our Caribbean Cultures"

Safety is a prerequisite to achieve a successful Parade!

- 1. Parade entries must be value-neutral, secular, and may not represent the specific political interest or ambitions of any political party or candidate.
- 2. Only a parade participant on foot may hand candy and other parade tokens directly to parade spectators. A parade participant may not hand out or throw candy or other parade tokens from a parade unit, regardless of whether the unit is stationary or moving. A parade participant or unit driver may not accept any items from parade spectators at any time.
- 3. No ticker tape or confetti will be used on the actual parade route by parade participants during the parade due to the creation of fire hazards, engine air-intake problems and clean-up costs.
- 4. If horse or other animals are entrants in the parade, the entrant must provide a pooper-scooper to clean up behind the animals. These entries are also required to clean the staging and de-staging areas.
- 5. Only animals under the strict leash or bridle of a qualified animal handler will be permitted in the parade. The identified animal handler and his/her parade unit sponsor will bear responsibility for any and all damages and injuries resulting from negligence or act of God incidents regarding the animal in question.
- 6. All owners and drivers of parade-related vehicles, and all other parade participants are bound by the parade entry registrant's signature on the Release and Waiver form protecting the <u>Caribbean American Phoenix Carnival Cultural Organization of AZ (CAPAZ) and the City of Phoenix and which is included as part of this Application/Registration Packet.</u>
- 7. Parade participants will not jump from or onto a float or motorized vehicle. No one is allowed on top of the tractor or in the space between the tractor and the trailer.
- 8. No tandem trailers or other trailers, where the wheels are in the center of the trailer, are allowed for units that have people on them.
- 9. All materials used for parade floats must be flame retardant and in compliance with City ordinance and parade code and standards.
- 10. The hitch used to attach a float to the pulling vehicle will be factory "receiver" type or welded pickup style bumper. No "bolt-on" type hitches will be allowed. When using a large truck, a "drop hitch" must be used and should be at least 12" from hitch to the ground.
- 11. Generators or other equipment that use flammable fuel will not be allowed on the float itself, unless approved in writing by the Fire Department. Generators used to supply electricity to the float

should be put in the bed of the pickup or hauling devices at least three feet from the float body. All generators must be grounded. Do not refuel generator while motor is running.

- 12. All generators, speakers or other equipment shall be adequately and appropriately secured to preclude any movement when a moving truck applies brakes or acceleration.
- 13. All trucks shall be enclosed with wooden or metal safety rails a minimum of 42" high. Only musicians and approved personnel are allowed in the enclosed area of the truck or trailer. All float participants standing on floats or any other motorized vehicles must wear safety belts or have hand holds or vertical stanchions (mounted to the float chassis with a u-shaped piece welded to the top bracket) or back supports securing them in place while the float or vehicles are in motion.
- 14. All drivers of floats or motorized vehicles must provide proof of vehicle liability insurance and a valid Arizona Drivers License 48 hours before the parade to CAPAZ. All drivers must have in their possession a valid Drivers License as appropriate.
- 15. A float can be no wider than 12 feet while in the parade or 8 feet while being towed without permit and police escort anywhere else in the City. In height, the tallest part of the deck people can stand on is to be no taller than 4 feet from the ground. No prop or item added to the deck can be taller than 12 feet from the top of the highest point to the ground.
- 16. At least one ABC fire extinguisher and a First Aid Kit are to be located within easy access on each float.
- 17. Only one individual shall be permitted to give directions to the driver. CAPAZ Official Marshals and/or Event Officials RESERVE THE RIGHT and are authorized to provide direction to the driver.
- 18. The Fire Department will inspect floats before the parade. If there are no fire extinguishers on board, or if the float is made of flammable materials, or there is some other violation, the float will be red-tagged and not allowed in the parade until these items are corrected.
- 19. The Police Department and Fire Department may exercise the authority to "veto" any aspect of the parade that they feel poses an unreasonable risk of injury or danger to the public. While exercise of this veto should be prudent, and certainly permit event producers to revise any objectionable part of a plan, public safety must ultimately be the responsibility of the Police and Fire/Rescue Departments and related Public Agencies.
- 20. CAPAZ wishes to remind all participants that consumption of alcohol is strictly prohibited in the parade staging area, route, and de-staging area.

Failure to abide by these Rules, Regulations, and Safety Requirements may result in:

- 1. The immediate removal of the participant and/or parade unit from the parade.
- 2. The disqualification of the parade participant's and/or sponsoring organization's eligibility to receive parade prizes, including trophies and cash awards.
- 3. The issuing of citations to and/or the filing of criminal charges against or the arrest of the responsible participant and/or person driving the parade unit.
- 4. The disqualification of the parade participant's and/or sponsoring organization's or group's eligibility to participate in future CAPAZ Parades.
